The bidder should deposit in front of Auction Committee an amount of **Rs. 9,000.00 (Rupees Nine thousand only)** as EMD/Bid Security in ICAR-IIWM Account (Name of the A/c Holder: ICAR UNIT IIWM, Bhubaneswar, A/c No.: 2977002100000985, Type of A/c : Current Account, Name of the Bank: PUNJAB NATIONAL BANK, Branch: CHANDRASEKHARPUR, BHUBANESWAR-751016, IFSC Code: PUNB0297700) or in shape of Demand Draft before participating in the bidding process.
